I release and hold the **"RELEASED PARTIES"** harmless from any injury or loss to my person or property which may result from my participation in H.O.G. activities and EVENT(S). I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE THE **"RELEASED PARTIES"** FOR ANY INJURY OR RESULTING DAMAGE TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH, THE PERFORMANCE OF THEIR CHAPTER DUTIES IN SPONSORING, PLANNING OR CONDUCTING SAID EVENT(S).

St Paul HOG® Chapter Alcohol Policy

The consumption and use of alcohol is a serious personal responsibility involving the safety and welfare of family, riding friends, and the individual HOG® member. We believe that safe and responsible motorcycling activity is a major HOG® goal and that the use of alcohol before or during a Chapter riding event is not prudent, safe, responsible behavior.

Riding Events – Our Chapter had adopted a **NO ALCOHOL** policy during our rides. Consumption of alcohol immediately before or during a riding event will not be tolerated and will result in the exclusion of the offending party from the event or the cancelation of the ride. This is not a judgment of the use of alcohol, but a policy focused on the safety and protection of our members during an event. The choice to use alcohol after an event is left to the individual.

Non-Riding Events – the Chapter will not purchase or furnish alcohol during non-riding events. If the sponsoring dealer and /or Chapter decide that alcohol may be consumed at a Chapter activity, then the recommended approach will be to purchase from a vendor that is licensed to sell alcohol. **LIQUOR LIABILITY COVERAGE IS NOT PROVIDED BY THE CHAPTER GENERAL LIABILITY INSURANCE POLICY.**
